OF DISMISSAL

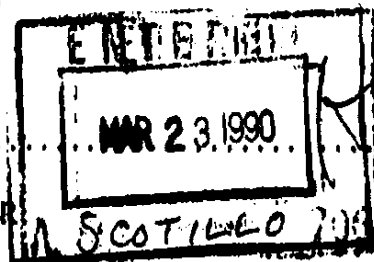
