## LEGAL DESCRIPTION

This letter is the official certification of the Comptroller of the Currency (OCC) for the merger of The First National Bank of Lake Bluff, Lake Bluff, Illinois (Charter No. 15502) and Lake Forest National Bank, Lake Forest, Illinois (Charter No. 15886) with and into The First National Bank of Lake Forest, Lake Forest, Illinois (Charter No. 8937), under the charter of the latter with the title of "Northern Trust Bank/Lake Forest National Association." It is understood that the effective date of the merger will be February 15, 1988.

This letter is also the official authorization of the Comptroller of the Currency allowing the receiving institution to operate the presently existing main office of The First National Bank of Lake Bluff and Lake Forest National Bank as branches of the receiving institutions. The locations and branch certificate numbers are detailed on the attached page.

Finally, this letter constitutes the official OCC certification of approval for the resulting bank to increase its common stock from \$4,500,000 to \$5,440,000 as part of the merger effective February 15, 1988.
