JUDGMENT FOR DISSOLUTION OF MARRIAGE

This cause coming on to be heard on January 7, 1987 and the
Petitioner appearing in her own person represented by DANIEL F.
GALLAGHER and LEVENFELD, GALLAGHER & GOLD, LTD., her attorneys, and
the Respondent having been personally served and having filed his
appearance pro se and the Court having heard the evidence and
testimony and being fully advised in the premises, the Court finds
as follows:

1. That it has jurisdiction of the parties hereto and
subject matter hereof.
2. That the Petitioner at the time of filing said petition
for dissolution of marriage was domiciled in and resided in the
State of Illinois and said domicile and residence have been
maintained for 90 days prior to the findings.
3. That the parties were lawfully married on January 26,
1985 and said marriage was registered in Las Vegas, Nevada.
4. That no children were born as a result of this marriage;

none were adopted, and the Petitioner is not now pregnant by the Respondent.

5. That the Petitioner is 28 years of age, employed as a bartender and resides at 7322 Blackstone, Justice, Illinois. The Respondent is 44 years of age, receives a disability pension from the Chicago Police Department, and resides at 7322 Blackstone, Justice, Illinois.

6. The Petitioner proved by competent evidence that the Respondent, during the course of the marriage, has been guilty of mental cruelty without cause of provocation on the part of the Petitioner.

7. That no real property was acquired during the course of the marriage and the parties have previously divided between themselves items of personal property, both marital and non-marital.

8. That each party testified in open court as to a waiver of maintenance.

WHEREFORE, based upon the evidence and testimony and on the motion of the attorneys for the Petitioner, it is hereby ordered:

a) That the bonds of matrimony heretofore existing between the Petitioner, WENDIE ANN BALTUTIS and the Respondent, ROBERT F. BALTUTIS, be dissolved as to both parties.

b) The parties have previously divided between themselves items of personal property both marital and non-marital and each party shall retain those items of personal property presently in their possession.

c) That based upon a mutual waiver of maintenance each party

shall be barred from maintenance.

d) The Respondent shall indemnify and hold Petitioner harmless on the mortgage balance on the 1986 Dodge pick-up truck.

e) The Petitioner may resume the use of her maiden name, White.

f) That the Court shall retain jurisdiction of this cause for the purpose of enforcing the terms of this judgment for dissolution of marriage.

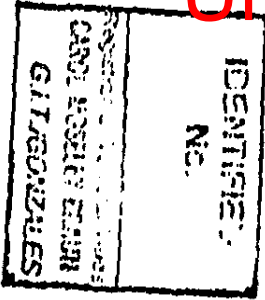
