- 5. That the Petitioner is 28 years of age, employed as a bartender and resides at 7322 Blackstone, Justice, Illinois. The Respondent is 44 years of age, receives a disability pension from the Chicago Police Department, and resides at 7322 Blackstone, Justice, Illinois.
- 6. The Petitioner proved by competent evidence that the Respondent, during the course of the marriage, has been guilty of mental cruelty without cause of provocation on the part of the Petitioner.
- 7. That no real property was acquired during the course of the marriage and the parties have previously divided between themselves items of personal property, both marital and non-marital.
