This Loan Modification Agreement (the "Agreement") is made and entered into as of this 7th day of September, 1990 by and between NBD Park Ridge Bank, an Illinois corporation ("Lender"), and NBD Trust Company of Illinois, not personally but solely as Trustee under Trust Agreement dated May 5, 1988 and known as Trust Number 66-5879 ("Borrower").

WITNESSETH

WHEREAS, Lender and Borrewer desire to modify the Loan Documents in the manner set forth hereafter.

NOW, THEREFORE, for Ten and No. 170 Dollars (\$10.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Lender and Borrower hereby agree as follows:

- Notwithstanding anything to the contrary contained in the Note, Mortgage or any other Land Loan Document, the maturity date of the Note is hereby extended to September 6, 1991, unless earlier due and pay total by reason of the acceleration of the maturity of the Note.
- The Land Loan Documents as expressly modified and amended by this Agreement, shall continue in full force and effect, and the Land Loar Documents as thus modified and amended are hereby ratified, confirmed and approved.
- This Agreement is executed by NBD Trust Company of Illinois, not personally but in its capacity as trustee as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such trustee, and it is expressly understood and agreed that nothing herein contained shall be construed as creating any liability on said trustee personally to pay the Loan or any interest that may accrue thereon, or any indebtedness accruing thereunder, or to perform any covenant either express or implied herein contained, all such liability, if any, being expressly waived by the trustee, and by every person now or hereafter claiming any right or security hereunder, and that so far as said trustee personally is concerned the legal holder or holders of said Note and, and the owner or owners of any indebtedness accruing thereunder shall look solely to the premises thereby conveyed for the payment, in the manner set forth in the Land Loan Documents.
