UNIFORM COVENANTS. Borrower and Lender coverant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Este Charges. Borrower shall promptly pay when due the principal of and interest off the debt evidenced by the Note and any prepayment and late charges due under the Note.

2.
