OF

RESTATED CERTIFICATE OF INCORPORATION

I DO HEREBY CERTIFY:

FIRST: That the amendment of the Corporation's Restated Certificate of Incorporation set forth in the following resolution was approved by the Board of Directors of the Corporation:

RESOLVED, that the FIRST Article of the Corporation's Restated Certificate of Incorporation be deleted in its entirety and replaced with the following:

FIRST. The name of the corporation (hereinafter called the "Corporation") is Transamerica Commercial Finance Corporation.

SECOND: That in lieu of a meeting and vote of stockholders, all of the stockholders of the Corporation have consented in writing to said amendment and said amendment was duly adopted in accordance with the applicable provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware.

THIRD: That the capital of the Corporation shall not be reduced under or by reason of said amendment.

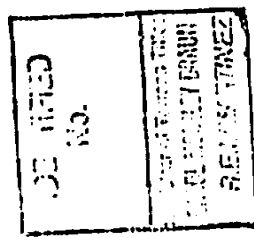

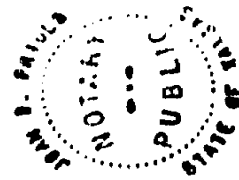
