- 6. That the parties hereto have at a prior time disposed of all personal property belonging to said parties by oral agreement.
- 7. The parties herein have waived all rights to maintenance and that said Petitioner has asked that the Respondent be barred from maintenance.

#### IT IS THEREFORE ORDERED ADJUDGED AND DECREED:
