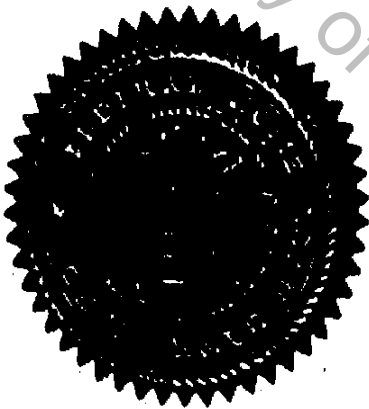


5. On December 14, 1984, Freedom Federal changed its corporate title to Freedom Federal Savings Bank;

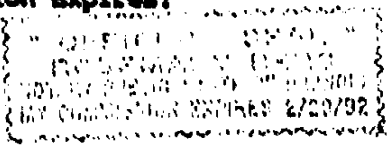

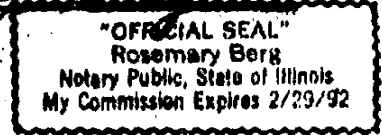
