(2) That in my capacity as Second Vice President-Real Estate of said Company, I have primary responsibility for managing and administering the real estate portfolio of the Company.

(3) Prior to its merger into Jefferson-Pilot Life Insurance Company, I held a similar position with Jefferson Standard Life Insurance Company and had similar responsibilities with Jefferson Standard Life Insurance Company, having held such responsibilities since 1982.

(4) In my above said positions, I am now, and have been since 1974, familiar with the real property and records pertaining to real property owned by Jefferson-Pilot Life Insurance Company and Jefferson Standard Life Insurance Company, including the property identified in Exhibit A attached hereto.

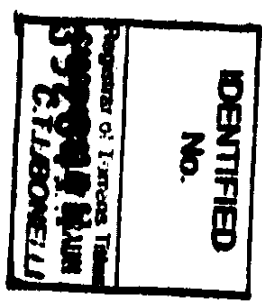
