The notice of the sale shall be published at least three consecutive calendar weeks, once in each week, the last such notice to be published not more than 5 days prior to the sale. After (1) the expiration of all the mortgagor's reinstatement and redemption rights and rights to possession (2) confirmation of the sale, and (3) payment of the purchase price and any other amount required to be paid by the purchaser at sale, the Court (or if the Court shall so order the person who conducted the sale or such person's successor or some persons specifically appointed by the Court for that purpose) shall upon the request of the holder of the Certificate of Sale (or the purchaser if no certificate of sale was issued) promptly execute a deed to the holder or purchaser sufficient to convey title.
