4. Hazard Insurance. 6. Protection of Lender's Rights in the Property. 9. Borrower Not Released; Forbearance by Lender Not a Waiver. 14. Assignment by Lender. 18. Acceleration; Remedies. 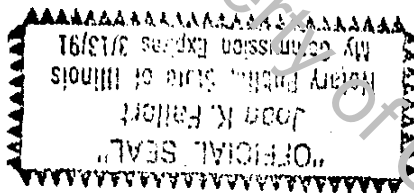
