DESIGNATION OF NORTHERN TRUST BANK/LAKE FOREST N.A. AS SUCCESSOR TRUSTEE TO NORTHERN TRUST BANK/O'HARE N.A. OF CERTAIN LAND TRUSTS

1. 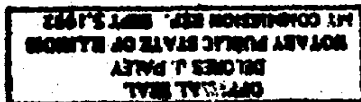

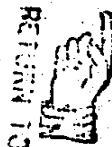

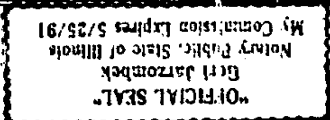
