WHEREAS, A Verified Certificate of Amendment has been filed in the Office of the Commissioner of Banks and Trust Companies, showing action of the stockholders of DROVERS BANK OF CHICAGO, located at 1542 West 47th Street, Chicago, County of Cook, State of Illinois, at a Special meeting held on the 24th day of February, 1987, amending its charter, to provide "that the name of the Bank be changed from Drovers Bank of Chicago to Cole Taylor Bank/Drovers", and

WHEREAS, It appears from the evidence submitted to the Commissioner of Banks and Trust Companies that the provisions of Sections 17 and 18 of an Act of the General Assembly of the State of Illinois, known as the Illinois Banking Act, approved May 11, 1955, in force January 1, 1957, as amended have been complied with;

I hereby certify that at a meeting of the Board of Directors of the Drovers Bank of Chicago Bank, at the offices of the Cole-Taylor Financial Group, Inc., Northbrook, Ill., located at 1542 W. 47th St., Chicago, Illinois, held on the 22nd day of January

A.D. 1987, at which a quorum of said directors was present, it was resolved to call a special meeting of the stockholders of said bank for the purpose of considering the question of amending the charter of this bank so as to:

BE IT RESOLVED, that the amangement of the Bank shall submit a proposed amendment to the shareholders, at a special shareholders meeting to be called hereunder for February 24, 1987 at the offices of the Cole-Taylor Financial Group, Inc., that the Bank's charter be amended to provide that the name of the Bank be changed from "Drovers Bank of Chicago" to "Cole Taylor Bank/Drovers."

at the offices of the Cole-Taylor Financial Group, Inc., Northbrook, Ill., And I further certify that at a special meeting of the said stockholders held on the 24th day of

February, A.D. 1987, at ten o'clock A. M., pursuant to the notice required by Section 18 of an act of the General Assembly of the State of Illinois, known as the "Illinois Banking Act," approved May 11, 1955, in force January 1, 1957, as amended, which said notice, properly signed, was delivered personally (or deposited in the post office) at least thirty days before the time fixed for such meeting, properly addressed to each stockholder, stating the time, place and object of such meeting, and was published once each week, for three successive weeks in the Chicago Tribune

a newspaper printed in the City of Chicago County of Cook, State of

Illinois, the following resolution was adopted:

BE IT RESOLVED, that the actions of the Board of Directors of the Bank, taken at the regular meeting of the Board of Directors of January 22, 1987, be and the same is hereby ratified and they are hereby authorized to take all action and execute such documents as they deem necessary to effectuate the name change of the Bank including, without limiting the generality of the foregoing.

BE IT FURTHER RESOLVED, that the Bank's charter be amended so that the name of the Bank be changed from "Drovers Bank of Chicago" to "Cole Taylor Bank/Drovers," and that all action necessary to effectuate the same be taken. The actual timing of the name change of the Bank is within the discretion of the Bank's management, subject to the approval of the Charter Amendment by the Illinois Commissioner of Banks and Trust Companies.





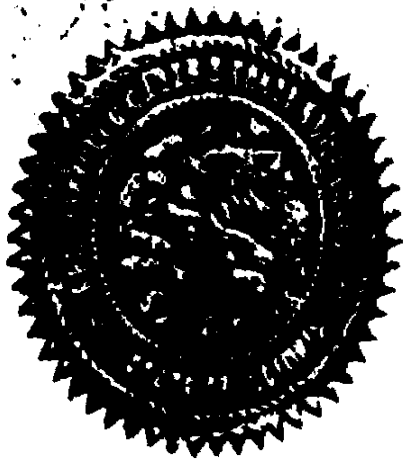
