The assignment of mortgage dated March 31, 1989 and filed March 28, 1990, as Document #LR3869236 is in full force.

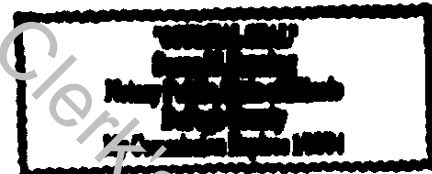

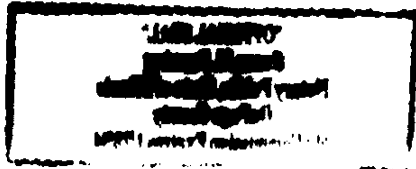
