2. That the Petitioner was a resident of the State of Illinois at the time the Petition for Dissolution of Marriage was commenced and has maintained residence in

the State of Illinois for ninety (90) days next preceeding the making of the findings; That the parties separated on October 4, 1986;

3. That the parties were married on the 8th day of October, 1977, that said marriage was registered in Chicago, Cook County, Illinois.

4. That one child was adopted by the parties as a result of said marriage; namely: Robert Kenneth Montos, age 20, and that the Petitioner is now now pregnant;

5. That irreconcilable differences have arisen between the parties through no fault of either party, and that their irreconcilable differences have destroyed the bonds;

6. That Petitioner has proven the material allegations of her Petition for Dissolution of Marriage by substantial, competent and relevant evidence; and that a Judgment for Dissolution of Marriage should be entered herein;

THEREFORE, ON MOTION OF SAID ATTORNEYS FOR THE PETITIONER, IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

A. That the parties are awarded a Judgment of Dissolution of Marriage, and that the bonds of matrimony existing between the Petitioner, NANCY ANN MONTOS, and the Respondent, NICK GEORGE MONTOS, are hereby dissolved;

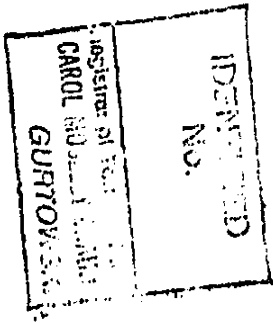
