Section 3-4. Explanation of powers granted in the statutory short form power of attorney for property and the effect of granting powers to an agent. When the little of any of the folio ving categories is retained (not struck out) in a statutory property power form, the effect will be to grant the agent all of the principal's rights, powers and discretions with respect to the types of property and transactions covered by the retained category, subject to any limitations on the granted powers that appear on the face of the form. - (d) Tangible personal property transactions. The agent is authorized to: buy and sell, lease, exchange, collect, possess and take title to all tangible personal property; may store, ship, restore, maintain, teptic, improve manage preservy, may and saltikeep tangible personal property; and, in general, exercise all powers with respect to tangible personal property which the principal could it present and under no popular.
- (e) Safe deposit box transactions.
