THIS INDENTURE, made April 22,

OFER AMRAM and LAURIE D. GARBER AMRAM, his wife,
herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of

EIGHTY EIGHT THOUSAND FIVE HUNDRED AND NO/100 (\$88,500.00) ----- Dollars, evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE ORDER OF BEARER

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from April 22, 1991 on the balance of principal remaining from time to time unpaid at the rate of 9½ per cent per annum in installments (including principal and interest) as follows:
