and reside at 3670 Lake Street, Lansing, Ill. 60438

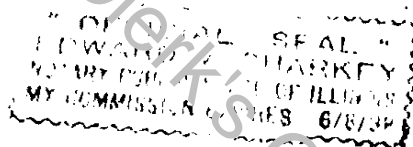
(2) I am personally acquainted with the affairs of the Estate of HENRY J. NORMAN, who died on October 21, 1977.

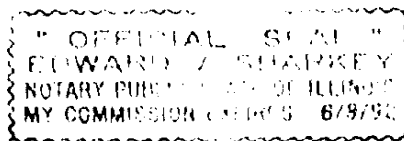

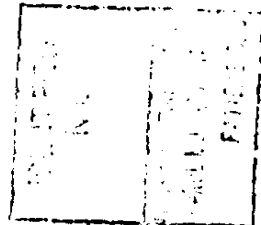
