BORROWER'S TRANSFER OF RIGHTS IN THE PROPERTY

BORROWER'S PROMISE TO PAY

PAYMENTS FOR TAXES AND INSURANCE

(A) Borrower's Obligations

(i) Barrower's Obligations

Each of my payments to Lender under this Paragraph 2 will be the sum of the following:

(a) Dhe-twenty-sixth of the estimated yearly taxes and assessments on the Property which under the applicable law may be superior to this Security Instrument; plus

(b) One-twenty-sixth of the estimated yearly leasehold payments or ground rents on the

Property, if any; plus

(c) One-twenty-sixth of the estimated yearly premium for hezard insurance covering the Property; plus

(d) One-twenty-sixth of the estimated yearly premium for mortgage insurance, if any.

i will give Lender all notices or bills that I receive for the amounts due under this Paragraph 2.

(ii) Lender's Obligations

If I make my payments to Lender, Lender will estimate from time to time my yearly faxes, hazard insurance premiums, assessments, leasehold payments, ground rents and mortgage insurance premiums, which items will be called the "impound/Escrow Items." Lender will use existing assessments and bills and reasonable estimates of future assessments and bills to estimate the impound/Escrow Items. The amounts that I pay to Lender for impound/Escrow Items under this Paragraph 2 will be called the "Funds."

Lender may hold the Funds. Except as described in this Paragraph 2, Lender will use the Funds to pay the Impound/Escrow Items. Lender will give to me, without charge, an annual statement of Funds activity.

Lender may not charge me for holding or keeping the Funds, for using the Funds to pay impound/Escrow item. For analyzing my payments of Funds, or for receiving, verifying and totaling assessments and bills. However, Londer may charge me for these services it Lender pays me interest on the Funds and if the few permits Lender to neker such a charge. Lender will not be required to pay me any interest or earnings on the Funds unless either (a) fewder and I agree in writing, at the time I sign this Security Instrument, that Lender will pay interest on the Funds.

(iii) Adjustments to ine Funds

If Lender's estimator of the Impound/Escrow Items are too high, the amounts that I pay under this Paragraph 2 will be too large.

If, at the time payments of impound?Escrow items are due, Lender has not received enough funds to make those payments, I will pay to Lender Whitever additional amount is necessary to pay the impound/Escrow items in full, I must pay that additional amount in one or more payments as Lender may require.

When I have paid all of the amounts due under the Secured Notes and under this Security Instrument, Lender will promptly refund to me any Funds that are then being held by Lender. If, under Paragraph 27 below, Lender acquires the Property or the Property is sold, then immunitely before the acquisition or sale, Lender will use any Funds which Lender is holding at that time to reduce the Sums Secured.

3. APPLICATION OF BORROWER'S PAYMENTS

Unless the law requires otherwise, Lender will apply each of my payments under the Secured Notes and under Paragraphs 1 and 2 above in the following order and for the following purposis:

First, to pay late charges due under the Secured Notes; Second, to pay prepayment charges due under the Secured Notes; Third, to pay any advances due to Lender under this Security Instrument; Fourth, to pay the amounts due to Lender under Paragraph 2 above; Fifth, to pay interest due under the Secured Notes; Sixth, to pay deterred interest under the Secured Notes; Last, to pay principal due under the Secured Notes.

4. BORROWER'S OBLIGATION TO PAY CHARGES, ASSESSMENTS AND CLAIMS

I will pay all taxes, assessments and any other charges and lines that may be imposed on the Property and that may be superior to this Security Instrument.

) will also make payments due under my lease if I am a tenant on the Property and I will pay ground rents (if any) due on the Property. I will pay these amounts either by making the payments to Lender that are described in Paragraph 2 above or by making the payments on time to the Person owed them.

Any claim, demand or charge that is made against properly because an obligation has not been fulfilled is known as a 1187. I will promptly pay or satisfy all liens against the Properly that may be superior to this Security instrument. However, this Security instrument does not require me to satisfy a superior lien it; (A) I agree, in writing, to pay the obligation which gave rise to the superior lien and Lender approves in writing the way in which I agree to pay that obligation; or (B) in good faith, I argue or defend against the superior lien in a lawsuit so that, during the lawsuit, the superior lien may not be enforced and no part of the Property must be given up; or (C) I secure from the holder of that other lien an agreement, approved in writing by Lender, that the

5. BORROWER'S OBLIGATION TO MAINTAIN INSURANCE

At my sole cost and expense, I will obtain and maintain hazard insurance to cover all buildings and other improvements that now are or in the future will be located on the Property. The insurance must cover loss or damage caused by fire, hazards normally covered by "extended coverage" hazard insurance policies and other hazards for which Lender requires coverage. The insurance must be in the amounts and for the periods of time required by Lender. I may choose the insurance company but my choice is subject to Lender's approval. Lender may not refuse to approve my choice unless the refusal is reasonable. All of these insurance policies and renewals of the policies must include what is known as a **Standard Mortgagee Clause** to protect Lender. The form of all policies and renewals must be acceptable to Lender. Lender will have the right to hold the policies and renewals. If Lender requires, I will promptly give Lender all receipts of paid premiums and renewal notices that I receive.

If I obtain earthquake insurance, any other hazard insurance, credit life and/or disability insurance, or any other insurance on or relating to the Property or the Secured Notes and which are not specifically required by Lender, I will name Lender as loss payee of any proceeds.

If there is a loss or damage to the Property, I will promptly notify the proper insurance company and Lender. If I do not promptly prove to the insurance company that the loss or damage occurred, then Lender may do so.

The amount paid by the insurance company is called "Proceeds." Any Proceeds received will be applied first to reimburse Lender for costs and expenses incurred in connection with obtaining the Proceeds, and then, at Lender's option and in the order and proportion as Lender may determine in its sole and absolute discretion, regardless of any impairment or lack or impairment of security, as follows: (A) to the extent allowed by applicable law, to the Sums Secured in r manner that Lender determines and/or (B) to the payment of costs and expenses of necessary repairs or to the restoration of the Property to a condition satisfactory to Lender, such application to be made in the manner and at the times as determined by Lender.

If I abandon the Property or if I do not inswer, within 30 days, a notice from Lender stating that the insurance company has offered to settle a claim, Linder may collect the Proceeds. Lender may use the Proceeds to repair or restore the Property or to pay the Sums seculed. The 30-day period will begin when the notice is given.

If any Proceeds are used to reduce the amount of principal which I owe to Lender under the Secured Notes, that use will not delay the due date or change the articular of any of my biweekly payments under the Secured Notes and under Paragraphs 1 and 2 above. However, Lanuer and I may agree in writing to delays or changes.

If Lender acquires the Property under Peragraph 27 below, all of my rights in the insurance policies will belong to Lender. Also, all of my rights in any proceeds which are paid because of damage that occurred before the Property is acquired by Lender or sold will belong to Lender. However, Londer's rights in those proceeds will not be greater than the Sums Secured immediately before the Property is acquired by Lender or sold.

If I am required by Lender to pay premiums for mortgage insurance, I will now the premiums until the requirement for mortgage insurance ends according to my written agreement with Lender or percording to law.

6. BORROWER'S OBLIGATION TO MAINTAIN THE PROPERTY AND TO FULTILE ANY LEASE OBLIGATIONS

I will keep the Property in good repair, I will not destroy or substantially change the Property and I will not allow the Property to deteriorate. I will keep and maintain the Property in compliance with up state or federal hazardous materials and hazardous waste laws. I will not use, generate, manufacture or more any hazardous materials or hazardous waste on, under or about the Property. I will indemnify, defend and hold harmless Lender and its employees, officers and directors and their successors from any claims, damages or costs for required or necessary repair or the removal of hazardous waste or any other hazardous materials claim. If I do not own but am a tenant on the property, I will fulfill my obligations under my lease. I also agree that, If I acquire the fee title to the Property, my lease interest and the fee title will not merge unless Lender agrees to the merger in writing.

7. LENDER'S RIGHT TO PROTECT ITS RIGHTS IN THE PROPERTY

if: (A) I do not keep my promises and agreements made in this Security instrument, or (B) someone, including me, begins a legal proceeding that may significantly affect Lender's rights in the Property (such as a legal proceeding in bankruptcy, in probate, for condemnation or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the Lender's rights in the Property, Lender's actions may include appearing in court, paying reasonable attorneys' fees and entering on the Property to make repairs. Lender must

give me notice before Lender may take any of these actions. Although Lender may take action under this Paragraph 7, Lender does not have to do so. Any action taken by Lender under this Paragraph 7, will not release me from my obligations under this Security Instrument.

I will pay to Lender any amounts which Lender advances under this Paragraph 7 with interest, at the interest rate in effect under the Secured Notes which have not been paid. I will pay those amounts to Lender when Lender sends me a notice requesting that I do so, interest on each amount will begin to accrue on the date that the amount is advanced by Lender, However, Lender and I may agree in writing to terms that are different from those in this Paragraph 7. This Security instrument will protect Lender in case I do not keep this promise to pay those amounts with interest.

8. LENDER'S RIGHT TO INSPECT THE PROPERTY

Lender, and others authorized by Lender, may enter upon and Inspect the Property. They must do so in a reasonable manner and at reasonable times. Before or at the time an Inspection is made, Lender must give me notice stating a reasonable purpose for the inspection.

9. AGREEMENTS ABOUT GOVERNMENTAL TAKING OF THE PROPERTY

I assign to Lender all my rights: (A) to proceeds of all awards or claims for damages resulting from condemnation entries domain or other governmental taking of all or any part of the Property; and (B) to proceeds from a sale of all or any part of the Property that is made to avoid condemnation, eminent domain or other government a sale of the property. All of those proceeds will be paid to Lender.

If all of the Property is taken, the proceeds will be used to reduce the Sums Secured. If any of the proceeds remain after the impount that I owe to Lender has been paid in full, the remaining proceeds will be paid to me. Unless tender and 'agree otherwise in writing, if only a part of the Property is taken, the amount that I owe to Lender will be reduced only by the amount of proceeds multiplied by the following fraction: (A) the total amount of the Sums Secured immediately before the taking, divided by (B) the fair market value of the Property Immediately before the taking. The remainder of the proceeds will be paid to me.

If I ebendon the Property or if . To not enswer, within 30 days, a notice from Lender stating that a governmental authority has offered to mike a payment or to settle a claim for damages, Lender has the authority to collect the proceeds. Lender may then use the proceeds to repair or restore the Property or to reduce the Sums Secured. The 30-day period will begin when the notice is given.

If any proceeds are used to reduce the a nount of principal which I owe to Lender under the Secured Notes, that use will not delay the due date or chang, the amount of any of my biweekly payments under the Secured Notes and under Paragraphs 1 and 2 above. "Two yet, Lender and I may agree in writing to delays or changes.

10. CONTINUATION OF BORROWER'S OBLIGATIONS AND OF LENDER'S RIGHTS

(A) Berrower's Obligations

Lender may allow a Person who takes over my right, and obligations subject to this Security Instrument to delay or to change the amount of the biweekly payments of principal and interest due under the Secured Notes or under this Security Instrument. Even if Lender does this, however, that Person and 1 will both still be fully obligated under the Secured Notes and under this Security Instrument.

Lender may allow those delays or changes for a Person who takes over my rights and obligations, even if Lender is requested not to do so. Lender will not be required to bring a lawsuit against such a Person for not fulfilling obligations under the Secured Notes or under this Security Institution, even if Lender is requested to do so.

(B) Lender's Rights

Even it Lender does not exercise or enforce any of its rights under this Security Instrument or under the law, Lender will still have all of those rights and may exercise and enforce them in the future. Even if Lender obtains insurance, pays taxes, or pays other claims, charges or liens against the Property, Lente, with have the right under Paragraph 27 below to demand that I make immediate payment in full of the amounts that I owe to Lender under the Note and under this Security Instrument.

11. OBLIGATIONS OF BORROWER AND OF PERSONS TAKING OVER BORROWER'S RIGHTS OR OBLIGATIONS

Any Person who takes over my rights or obligations under this Security Instrument will have all of my rights and will be obligated to keep all of my promises and agreements made in this Security Instrument, Similarly, any Person who takes over Lender's rights or obligations under this Security Instrument will have all of Lender's rights and will be obligated to keep all of Lender's agreements made in this Security Instrument.

If more than one Person signs this Security Instrument as Borrower, each of us is fully obligated to keep all of Borrower's promises and obligations contained in this Security Instrument. Lender may enforce Lender's rights under this Security Instrument against each of us Individually or against all of us together. This means that any one of us may be required to pay all of the Sums Secured.

MAXIMUM LOAN CHARGES

If the loan secured by this Security instrument is subject to a law which sets maximum foan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed permitted limits, then: (A) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limits and (B) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. If a change in applicable law would make any provision of the Secured Notes or this Security Instrument unenforceable, Lender may require that I make immediate payment in full of all Sums Secured by this Security instrument.

NOTICES REQUIRED UNDER THIS SECURITY INSTRUMENT

Any notice that must be given to me under this Security instrument will be given by delivering it or by mailing it by first class mall unless applicable law requires use of another method. The notice will be addressed atternative address in tigive Lender a notice of my atternative address. I may designate only one mailing address at a time for notification purposes. Any notice that must be given to Lender under this Security instrument will be given by mailing it 15 first class mail to Lender's address stated in Section I.(C) above entitled, "Definitions of Words Used in This Mirrage," unless Lender gives me notice of a different address. Any notice required by this Security instrument is give; when it is mailed or when it is delivered according to the requirements of this Paragraph 14 or of applicable Irw.

GOVERNING LAW: SEVERIBILITY

This Security Instrument and the Secured Notes shall be governed by and construed under federal law and federal rules and regulations in luding those for federal savings and loan associations, called "Federal Law." In the event that any of the terms or provisions of this Security Instrument or the Secured Notes are interpreted or construed by a court of competent jurisdiction to be void, invalid or unenforceable, such decision shall affect only those provisions so construed or interpreted and shall not affect the remaining provisions of this Security Instrument or the Secured Notes.

BORROWER'S COPY

I acknowledge the receipt of one conformed copy of the Secured Notes and of this Security instrument.

LENDER'S RIGHTS TO RENTAL PAYMENTS AND TO JAKE POSSESSION OF THE PROPERTY if Lender requires immediate payment in full or if i condon the Property, then Lender, persons authorized by Lender, or a receiver appointed by a court at Lender's fequest may: (A) collect the payments, including overdue rental payments, directly from the tenants; (B) entir upon and take possession of the Property; (C) manage the Property; and (D) sign, cancel and change routal greements and leases. The cantions and headings at the beginning of each paragraph of this Security Instrument are for reference only and will not be used in the interpretation of any provision of this Security Instrument.

MODIFICATION 23.

This Security instrument may be modified or amended only by an agreement in writing signed by Borrower and Lenda .

Lender may modify the Securif, instrument and the Secured Notes at Lender's sole discretion in the event that I have falled to make my biwue'ly payments in the manner set forth in the Secured Notes.
