CLAIM FOR LIEN

- 3. On or about April 20, 1990, claimant made a written contract with F. Dennis Rotunno to furnish all labor, material, tools and equipment and to perform all work necessary to complete the remodeling of the above-described real property.
- 4. The balance now due and owing to claimant from owner for work performed to improve the above-described real property, after allowing all credits, is \$105,020.

WHEREFORE, Olson Bros. & Sons Construction Company, Inc. hereby claims a lien upon the real property described above and any improvements thereon in the amount of \$105,020, together with interest as provided by statute, the cost of enforcement of this lien, and other such costs and expenses as provided by law.
