KNOW ALL MEN BY THESE PRESENTS, that whereas COMMUNITY BANK & TRUST COMPANY OF EDGEWATER, an Illinois banking corporation, hereinafter call d "Assignee" is the owner of the note in the principal amount of \$ 250,000.00 executed by JAMES E, KEUP AND JOSEPH J. MAGGIO, as joint tenants

and secured by a mortgage, deed of trust or security deed dated June 28, 19 91 and recorded or registered in the office of Registrar of Titles Cook County, State of Illinois, on property

now owned by JAMES E. KEUP AND JOSEPH J. MAGGIO, as joint tenants hereinafter called "Assignor", and legally described as follows:

Lot 2 in the Subdivision of Lots 11 and 12 in Block 3 in John Lewis Cochran's Subdivision of the West 1/2 of the North East 1/4 of Section 8, Township 40 North, Range 14 East of the Third Principal Maridian, in Cook County, Illinois Affects Parcel 2; Commonly known as 1048 W. Barwyn, Chicago, IL 14-08-208-028

Lot 1 in the Subdivision of Lots 11 and 12 in Block 8 in John Lewis Cochran's Subdivision of the West 1/2 of the North West 1/4 of Section 8, Township 40 North, Range 1/ East of the Third Principal Maridian, in Cook County, Illinois Affects Parcel 3, Commonly known as 1050 W. Berwyn, Chicago, IL 14-08-208-027

and whereas Assignor desirer further to secure to Assignee the full and complete performance of each of the coverants, agreements and promises contained in the bond or note and mortgage, deel of trust or security deed referred to above:

NOW, THEREFORE, in consideration of the premises and of the sum of One Dollar and other good and valuable considerations to Assignor in hand paid by Assignee, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, transfer and set over unto Assignee the possession of the mortgaged property above described, and of all the rents, issues and profits now due or to become due and derived from such property, until the obligation above referred to shall have been fully paid and satisfied or until Assignee shall be entitled to such possession by order of court or operation of law, such assignment to be subject to the following terms and conditions:

- 1. Until default shall have 'dourred in the full and complete performance of any of the agreements, covenants and promises in the bond or note and mortgage, deed of trust or security deed, Assignor may continue to collect the rents, issues and profits from the above property. Upon occurrence of such a default Assignor shall deliver to Assignee all leases of the premises above described, or any portion thereof. This assignment of rents shall be an assignment of all such leases to Assignee and Assignor will execute any further assignment necessary to perfect the transfer of such leases to Assigner.
- All sums collected and received by Assignee out of the rents, issues and profits of such property shall be first applied by it to the payment of: the costs of collection thereof; the costs of management, repairs and unkeep of the property, including the purchase of such additional furniture (in equipment as the Assignee in its sole discretion may deem necessary for the maintenance of proper rental value of the proprity; all tuxos, assessments, premiums for public liability insurance and insurance premiums payable by the mortgagor or grantor as provided in the mortgage or deed of trust described above and any taxes imposed upon or collectible by Assignee under any federal or state law or any law or ordinance enacted by any political subdivision thereof, or any aupplements or amendments thereto, provided, however, that such tax shall be based upon the employment by Assignee of persons necessary to the operation of the property under this assignment. Second, the balance, if any, which shall be known as "the net income", shall be applied toward the reduction of the mortgage indebtedness and interest accrued thereon. Trovided, however, that no credit shall be given by Assignee for any sums received from the rents, issues and profits of the property until the money collected is actually received at Assignee's home office and no credits shall be given for any uncollected rents or other uncollected amounts or bills, nor whall credit on the mortgage indebtadness be given for rents, issues and profits derived from the property after Assignee shall obtain possession of the premises under order of court or by operation of law.
