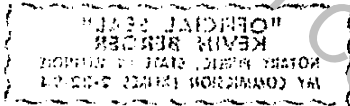
## ASSIGNMENT OF REAL ESTATE MORTGAGE

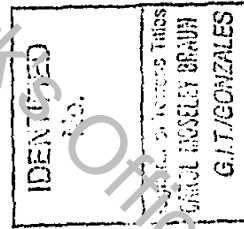
