AGREEMENT FOR DEED IN LIEU OF FORECLOSURE

WHEREAS, JOHN H. HENDERSON and DOROTHY HENDERSON, his wife (hereinafter "Mortgagors") executed a Trust Deed and Installment Note in favor of the FIRST NATIONAL BANK OF BLUE ISLAND (hereinafter "Bank") copies of which are attached hereto as Exhibits "A" and "B";

WHEREAS, Bank has agreed to forebear from filing a Mortgage foreclosure proceeding if the mortgagors enter into this Agreement;

WHEREAS, both the Mortgagors and Bank wish to resolve the existing delinquency, in that the Note has been delinquent since August 8, 1990, by entering into this Agreement;

WHEREFORE the parties agree as follows:

- 1. Morigagors agree to simultaneously execute a Warranty Decd in duplicate originals (copy attached hereto as Exhibit "C") to the real estate in said Trust Deed to Bank thereby conveying good title to Bank and thereby conveying all interests of Mortgagors to Bank;
- Mortgagore refree to deliver possession (in good and clear condition) of all improvements located upon said real estate to Bank by May 28, 1991.
- 3. Bank hereby agrees that, upon the recording of said Warranty Deed corveying good title to said Bank, Mortgagors shall thereby be immediately released from all personal liability from said Trust Deed and Note.
- 4. This Agreement shall become fully effective and binding upon the recordation of Laid Warranty Deads.
