L E G A L D E S C R I P T I O N

Parcel 1: Beginning at a point on the extended East Line of Lot 10 in the Subdivision of that Part of Lot 17, in the Assessor's Division of the West 1/2 of the Northwest 1/4 and the West 1/2 of the Southwest 1/4 of Section 15, Township 37 North, Range 14, East of the Third Principal Meridian, a Distance 8 Feet North along said extended line from the Northeast corner of said Lot 10, running thence North along said extended East Line to the South Line of Lot 9, in Cornelius Kuyper Sr's.
