THIS INDENTURE, made this 27th day of August 1991, between FIRST CHICAGO TRUST COMPANY OF ILLINOIS, formerly known as Bank of Ravenswood, hereinafter referred to as First Chicago Trust Company, an Illinois Corporation as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said bank in pursuance of a trust agreement dated the 25th day of October 1985, and known as Trust Number 25-7415, party of the first part, and The Chicago Housing Authority, c/o The Habitat Company, as Receiver of the second part, Address of Grantee(s), 405 North Wabash Avenue, Chicago, Illinois 60611.


