- 1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.
- 2. Funds for Taxes and Insurance. Subject to applicable law or to a written waiver by Lender. - 13. Loan Charges.   - 16. Borrower's Cap., Borrower shall be given one conformed copy of the Note and of this Security instrument.
- 17. Transfer of the Fromity or a Beneficial Interest in Borrower. It all or any part of the Property or any interest in it is sold or transferred (or it a honeficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent. Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument. However, this option is chall not be exercised by Lender if exercise is prohibited by federal law as of the date of this Security Instrument.

- 19. Sale of Note: Change of Loan Servicer. The Note or a partial interest in the Note (together with this Security Instrument) may be sold one or more times without prior notice to Borrower.
