## UNOFFICIAL GORY

### SECOND MODIFICATION AGREEMENT

This SECOND Modification of the Installment Note, Trust Deed, Assignment of Rents, and Guaranty Agreement ("Second Modification Agreement") is made on JULY 10, 1991, between OAK BROOK BANK, not personally but as successor Trustee under a Trust Agreement dated DECEMBER 10, 1975, and known as Trust Number 164 ("First Party"); NBD WOODFIELD BANK ("Trustee"); and WARREN J. HAEGER ("Guarantor").

#### WITNESSETH:

Whereas, First Party executed and delivered to Trustee that certain Installment Note dated JANUARY 10, 1986, in the amount of ONE HUNDRED SEVENTY THOUSAND AND CC/100 DOLLARS (\$170,000.00) ("Note"), which Note is secured by a Trust level ("Trust Deed") of even date therewith, registered on JANUARY 30, 1986, in the Registrar's Office of COOK County, Illinois, as Document Number LR3493144 and Assignment of Rents ("Assignment") of even date therewith, registered on JANUARY 30, 1986, in the Registrar's Office of COOK County, Illinois, 53 Jocument Number LR3493145, on property as more fully described in Exhibit "A" a'Niched hereto and made a part hereof ("Premises"); and

Whereas, Guarantor executed and delivered to Trustee that certain Guaranty Agreement dated FFRUARY 10, 1991, in the amount of ONE HUNDRED FIFTY-EIGHT THOUSAND THREE HUNDRED AND 00/100 DOLLARS (\$158,300.00); and

Whereas, Guarantor hereby requests the Trustee modify and extend the Note, Trust Deed, and Assignment; and

Whereas, First Part', Guarantor, and Trustee agree to enter into this Second Modification Agreement.

Now, therefore, in consideration of the mutual covenants and conditions herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby removed deed, the parties hereto agree that the Note, Trust Deed, and Assignment are hereby modified as follows:

- 1. That, as of the date her of, the outstanding principal amount of the Note is ONE HUNDRED FIFTY-SEVEN THOUSAND THREE HUNDRED TWENTY-FIVE AND 00/100 DOLLARS (\$157,325.00).
  - 2. That, the maturity date is extended to JULY 10, 1996.
- 3. That, payments shall be due month) beginning on AUGUSE 1, 1991, and on the same day of each month thereafter, consisting of ONE HUNDRED NINETY-FIVE AND 00/100 DOLLARS (\$195.00) principal rlus interest in arrears on the principal balance from time to time outstanding, with a final payment of all the outstanding principal and accrued interest due and payable on JULY 10, 1996.
- 4. Except for the modifications stated hereinables, the Note, Trust Deed, Assignment, and Guaranty Agreement are not otherwise changed, modified or amended.

This Second Modification Agreement is executed by CAK BROOK BANK, not personally but as Trustee as aforesaid in the exercise of the power and authority conferred upon and vested in it as such Trustee (and said Trustee hereby warrants that it possesses full power and authority to execute this instrument), and it is expressly understood and agreed that rothing herein contained shall be construed as creating any liability on said Trustee personally to perform any covenant either expressed or implied herein contained, or such liability, if any, being expressly waived by every person now or hereafter claiming any right or security hereunder.


