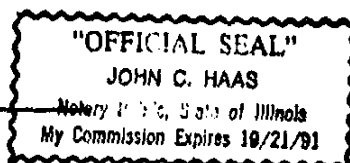

LAST WILL AND TESTAMENT

OF

CARMEN A. PERRINO

I, CARMEN A. PERRINO, of the Village of Mt. Prospect County of Cook, State of Illinois, being of sound and disposing mind and memory, do make and declare this to be my Last Will and Testament. I hereby revoke all prior Wills and Codicils that I may have made.

I

I order and direct my Executor, hereinafter named, to pay all my just debts and funeral expenses as soon after my decease as conveniently may be done.

II

I direct that my estate and inheritance taxes and other governmental charges assessed by reason of my death, be paid out of the residue of my estate without seeking reimbursement or charging any person for any part of the taxes and charges so paid.

III

All of my residuary estate, whether real or personal, wheresoever situated, I give, devise and bequeath to my wife, JEANNETTE M. PERRINO, as her absolute property forever, provided she shall survive me for a period of thirty (30) days.

IV

In the event my wife, JEANNETTE M. PERRINO, shall not survive me for a period of thirty (30) days, I give, devise and bequeath all of my residuary estate to my nieces, MARIE CAPPILUPO and JANET ANN TIMBERLAKE, share and share alike. If

either of my nieces have predeceased me, then the living descendants of a deceased niece shall take per stirpes the share the niece would have received if she was living.

V

In the event my wife, JEANNETTE M. PERRINO, shall survive me for a period of thirty (30) days, I nominate and appoint her as Executor of this my Last Will and Testament, and in the event she shall fail, refuse or cease to act as Executor, I nominate and appoint MT. PROSPECT STATE BANK, Mt. Prospect, Illinois, as Successor Executor. No surety or other security shall be required on the bond of any Executor or Successor Executor acting hereunder.

VI

I give to my Executor or Successor Executor full power and authority, without authorization by any Court, to sell, exchange, mortgage, pledge, hypothecate, lease, retain, repair or otherwise deal with the whole or any part of my estate, real or personal, for such prices, on such terms and to such persons as the Executor may decide. My Executor may invest in stocks, bonds, notes, certificates of deposit or other property of any kind, real or personal, and may vote, in person or by proxy, any shares of stock owned by my estate. Such Executor may make distribution of my estate wholly or partly in kind; may pay, settle, compromise, contest, prosecute or abandon any or all claims in favor of or against my estate as such Executor deems best; and for any of the aforesaid purposes may employ agents and attorneys, and may make, execute and deliver any and all deeds, mortgages, bills of sale, releases or other instruments necessary or desirable therefore.

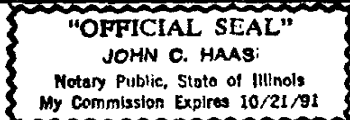
