WITNESSETH, that said party of the first part, in consideration of the sum of \$100 dollars, and  
other good and valuable considerations in hand paid, does hereby Quit Claim and convey unto said  
parties of the second part, in joint tenancy, the following  
described real estate, situated in Cook County, Illinois, to wit:  
That part of Lot 5 in the Subdivision of Joseph A. Barnes' Farm, in Section 9,  
15 and 16, Township 41 North, Range 11, East of the Third Principal Meridian,
