2. That pursuant to the Corporate Fiduciary Act, Article III, SEC. 3-4 (par. 1553-4) Affiliated Bank/Western National succeeded to all of the trust business of FSB effective July 26, 1988, and;
3. That Affiliated Bank/Western National and Manufacturers Affiliated Trust Company are subsidiaries of Manufacturers National Corporation, and;

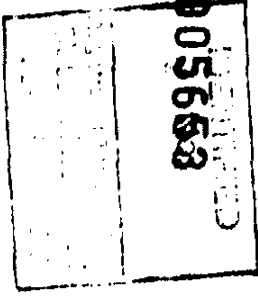
