Illinois on August 23, 1990 as Document No. 3906442 And extended to January 15, 1991 by a 2nd Note and Mortgage Modification Agreement in the amount of THIRTY-THREE THOUSAND TWO HUNDRED EIGHTY-THREE AND 34/100 DOLLARS (\$33,283,34) recorded in the Office of the Recorder of Deeds of Cook County, Illinois on December 26, 1990 as Document No. 3934636 and further extended to July 15, 1991 by a 3rd Note and Mortgage Modification Agreement recorded in the Office of the Recorder of Deeds of Cook County, Illinois on March 7/21991 as Document No. 3947980."

WHEREAS, the Note is secured by a Mortgage (the "Mortgage") dated July 28, 1988 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on August 26, 1988 as Document No. 3734746 affecting real property described on Exhibit "A", which is attached hereto and made a part of hereof; and
