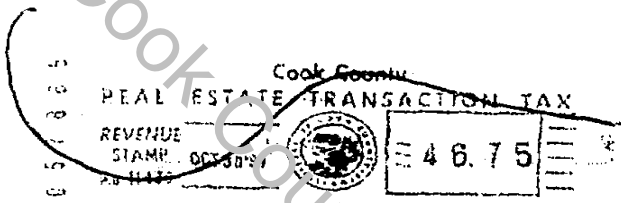
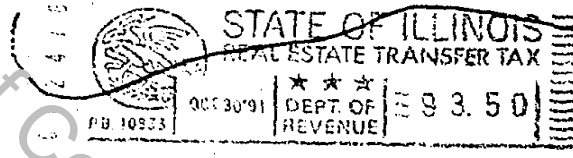
THIS INDENTURE, made this 22nd day of October, 1991, between

 and easements, covenants, conditions, restrictions and unpaid taxes or assessments of record, if any.

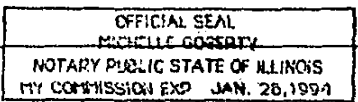
