WHERIA3, Pursuant to Section 21(b)(4) of the Federal Home Loan Bank Act, as smended by Section 501 of FIRREA, among other powers, the RTC as conservator may exercise any eathority granted to the FDIC under Sections 11, 12, and 13 of the Federal Deposit Insurance Act as amunded by Section 212, 213, 214, 216, and 217 of FIRREA:
