WHEREAS, Owners desire and in tend to refinance their existing first Mortgage with CHASE MANHATTAN FINANCIAL SERVICES, INC. renewal or extension thereof, including monies advanced under said mortgage loan and to be advanced under said mortgage loan shall be subject and subordinate to the lien of the First Mortgage in favor of the First Mortgagee in the same manner and to the same extent as if such Second Mortgage had been executed and recorded subsequent

to the execution, delivery and recording of the First Mortgage.
2. That from the proceeds of the new First Mortgage payment shall be made in full of that certain existing first Mortgage lien held by CHASE MANHATTAN FINANCIAL SERVICES, INC. D/B/A CH MANHATTAN OF ILLINOIS, dated DEC 19 1991, recorded DEC

MANHATTAN OF ILLINOIS, dated DEC 9 1991, recorded DEC 1991 as Document No. \_\_\_\_ with the Recorder of Deeds of Cook County, in the original principal amount of \$176,000.00 and a Release of said Mortgage obtained and recorded as part of the loan closing transaction.

That Second Mortgage certifies there are no known defaults on the part of the Owners under the Second Mortgage, and that said

Second Mortgage has not been amended or modified.

4. That this Agreement may not be modified other than by an Agreement in writing signed by all parties hereto or by their respective successors in interest.

5. This acreement shall inure to the benefit of and be binding upon the parties hereto and their heirs, Legal Representatives, successors and assigns.
