

That on March 1, 1993, said contractor made a subcontract with the claimant to furnish lumber, millwork and miscellaneous building materials for and in said improvement, and that on July 27, 1993, the claimant completed thereunder all required to be done under the aforementioned agreement by the delivery of said materials to the value of FORTY-EIGHT THOUSAND SEVEN HUNDRED EIGHTY-EIGHT DOLLARS AND 21/100 (\$48,788.21).

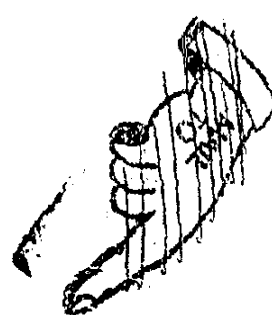

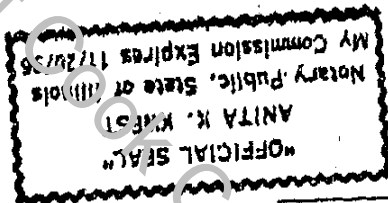
